

About Our Program

Florida Community Health Centers, Inc. offers a Sliding Fee Discount Program, to all income eligible, uninsured, or underinsured patients. The program is designed to reduce barriers to accessing health services, by offering medical and dental services at a discounted fee to those who qualify. Eligibility for the Sliding Fee Discount Program will be determined based on the Federal Poverty Guidelines. The Sliding Fee Discount Program requires valid proof of income, household size, and completion of a household assessment. All patients can apply for the program, even if you are insured. Florida Community Health Centers, Inc., will not turn a patient away due to their inability to pay.



How to determine household size

A household is defined as any group of individuals, with or without children, living under the same roof that combine their income for monthly bills. Persons in the household may or may not be related.

Program Pricing per Visit

All payments are due at the time of service.

Medical/Dental

- Slide A: \$20.00 for patients at or below 100% of the federal poverty guidelines.
- Slide B: \$30.00 for patients at 100% - 125% of the federal poverty guidelines.
- Slide C: \$40.00 for patients at 125% - 150% of the federal poverty guidelines.
- Slide D: \$50.00 for patients at 150% - 175% of the federal poverty guidelines.
- Slide E: \$60.00 for patients at 175% - 200% of the federal poverty guidelines.

OB/GYN

- Slide A: \$35.00 for patients at or below 100% of the federal poverty guidelines.
- Slide B: \$45.00 for patients at 100% - 125% of the federal poverty guidelines.
- Slide C: \$55.00 for patients at 125% - 150% of the federal poverty guidelines.
- Slide D: \$65.00 for patients at 150% - 175% of the federal poverty guidelines.
- Slide E: \$75.00 for patients at 175% - 200% of the federal poverty guidelines.

**Patients above 200% of the federal poverty guidelines are not eligible for sliding fee discounts.*

Proof of Income

Proof of income is required to qualify for the Sliding Fee Discount Program, and may include the following:

- Most current tax return
- W-2 forms
- Three most recent pay-stubs.

Other forms of verification may require approval by the Center Administrative Director (updated every 6 months). Failure to provide proof of income as required will cause you to be responsible for 100% of all charges.

Important Information

- A fee based on your approved discount level will be expected at the time of service. Specialty services may charge a different fee. These fees may include other services such as a basic lab, x-rays, etc. FCHC participates in state and federal vaccine programs. These services may be free of charge
- If your income or household size changes, at your next visit, bring proof of the updated income or household size. The changes may effect your discount level. Any changes must be reviewed and approved by the Center Administrative.
